Report of the Service Officer

Art Haussler shared the importance of reviewing the VFW, American Legion and DAV web pages as they have action items . They are pre-written letters that you can enter your name and service number and send in. Your participation provides feedback to Congress and other organizations. He additionally shared Senate Bill 656, Veteran Improvement, the Commercial Driver License Act of 2023. The bill aims to change the rules for the Secretary of Veteran Affairs to approve commercial driver education programs for Veterans education assistance. Its purpose is to fund training in those jobs can be covered by the GI Bill now. Next, the VA has determined they will pay for caskets in the ground. The VA has learned cemetery inventories are getting filled quickly. Many have been dropping down inside their place of interment because of erosion. The VA will absorb the cost to fix the problem. Thirdly, the 700th Veteran of the Korean conflict has been recovered. An additional item of discussion was radiation exposure in Uzbekistan. This affects a younger group of Veterans. There isn't a lot of history to share yet, but the VA is working on the issue. Please watch our website to be aware of these and many other issues. The American Legion is doing the same thing, keeping apprised of issues in all regions inclusive of Washington D.C.
