Report of the Service Officer

The PACT Act has been in force for 2.5 years now. A recent survey of all the records going back to World War II is in process, and they're looking at and claiming that for Veterans who face toxic issues, it has taken 34.1 years for them to get acknowledged. COLA increased 2.5% effective January 1st. Raises for Junior enlisted troops as well. Congress has approved two fast attack submarines and 3 destroyers. Selective Service rules are changing and all males up to the age of 26 would be listed for service. Additionally, Females will be required to register for the Selective service as well. Other news, 578 personnel from the Air National Guard will transfer into the Space Force. The next item, Toys for Tots program started in 1947. A well-appreciated program.

PTSD is still an issue. A flyer was offered for members to review by a post member. Along with that the VA has a PTSD app for your phone to help Veterans. Information is kept confidential.
